



# Exotic Newcastle Disease in Poultry in California

Exotic Newcastle Disease (END) was diagnosed in backyard poultry flocks in Southern California on October 1, 2002. END is a very serious contagious and often fatal viral disease that affects most species of birds ([LINK to END – Information for Bird Owners Fact Sheet](#)). Birds with END may have respiratory, nervous, or gastrointestinal signs, but birds may die without showing any signs. Some bird species can be infected without showing signs of disease and spread the disease to other birds with fatal consequences.

The California Department of Food and Agriculture (CDFA) and the United States Department of Agriculture (USDA) are currently conducting an eradication campaign for END. The disease is restricted to poultry in **Los Angeles, Riverside, San Bernardino, and San Diego Counties**. Officials are going door-to-door to find sick birds in affected areas and tracing birds into and out of infected flocks.

**Exotic Newcastle Disease is not a public health threat and does not affect the safety of poultry or eggs.**

A regional quarantine ([LINK to Quarantine Notice](#)) is in place to prevent the spread of Exotic Newcastle Disease. This quarantine affects poultry exhibitions and owners of birds (listed species) within the quarantined area ([LINK to map](#)).

### Bird Species Under Quarantine

**Chickens, turkeys, ducks, geese, grouse, partridges, pheasants, quail, guinea fowl, peafowl (peacocks), doves, pigeons, swans, and ratites (emus, ostriches, rheas, etc.).**

Owners of any species of birds affected by the quarantine are prohibited from moving birds and bird products out of the quarantined area.

Shows and sales of poultry within the quarantined area are **only** permitted if the event manager has a signed compliance agreement with the CDFA. Poultry that enter the quarantined area for exhibition or sale are **NOT** permitted to leave the area.

Any gathering of birds increases the risk of spreading disease. It is strongly recommended that no birds of any species be moved into, within, or out of the quarantined area. This quarantine will remain in effect until Exotic Newcastle Disease has been eradicated from California. Anyone who violates the quarantine is civilly liable in an amount not to exceed \$25,000.

- Over 637 people are working to eradicate this disease.
- 5,712 premises have been quarantined (i.e., birds are not allowed to leave these premises); investigations are ongoing.
- 1,206 of these premises contained birds infected with or exposed to END; all birds in these flocks have been or will be humanely destroyed. All affected premises are being cleaned and disinfected after the birds have been removed.
- Owners are being compensated at “fair market value” for birds that are destroyed.
- Owners will be allowed to restock birds after there is no risk of them being reinfected with END.
